


## Syllabus Submission Step-by-Step Guide

### Step 1: Log into Canvas and Enter Your Syllabus Submission Shell

- Visit the VikingPortal and enter Canvas
- Upon login, a "Syllabus Submission" Shell should appear in your Canvas Dashboard. Click it to enter:







	COURSE OUTLINE PUBLIC V	This introductory course serves as a louncation for increasing the intrinsic connection of language and culture using anthropological methodologies. Language is presented as a shared system of symbols that encodes various cultural realities in Western and non-Western societies. This course surveys three core areas in linguistic anthropology: Structural Linguistics—phonology, morphology, syntax, and semantics; Historical linguistics—origins and evolution of language, the development of language over time including its changes, variations, and language loss; and Sociolinguistics— language acquisition in a cultural context, how culture shapes language, and the intersection of language and systems of power.
