- It was suggested that the Performing Arts dance classes be moved closer to the auditorium as a general health screening station in the LAC quad will be placed near the E building.
- > Per Business Support Services, please include queuing areas in distancing diagrams.
- As plans are being developed, inviting those who will be working in a particular area to join the walk-thru might be a way of alleviating some of the concerns around returning to campus while also allowing them to see the safety measures being put into place prior to their return.
- Laser pointers can be used to help faculty assist students in computer labs and study spaces while also allowing them to maintain social distancing.
- Current Computer Lab plans do not allow for printing; this may be revisited later once more staff support is available.
- The request was made to repair the lift by L 251 if it is not yet operational.
- As all plans are approved, please forward the information to those handling the Essential Personnel List so that the list can be updated.
- As long as it is approved by the area supervisor, employees may come on campus daily (between 8am-5pm.)
- ➤ Do not open conference rooms at this time, unless a small conference room is needed for single person use.
- > Important to create a space that reassures people that returning is safe.
- "Close Contact" is defined as being within 6 feet of someone for 15 minutes or more (passing someone in a hallway while both are masked does not qualify as close contact.)
- The Performing Arts, Computer Labs and Office Access Plans were all approved for implementation by the Reopening Task Force Steering Committee.
