BUILDINGS Q+R WALL WRAPS PROJECT

Scope Overview: This project consists of design and installation of cast wrap vinyl wall graphics on the East and West walls of the Building Q Gym and the South corridor of Building R and a silicon edge fabric graphic system in the Building R Gym, per District-issued photos and detail.

Project Estimate: \$65,000

Project Duration: 77 consecutive calendar days

License Requirement: At the time bids are submitted, each Bidder shall possess a valid Class **B and/or C-61/D-29** contractor's license and must maintain the license(s) throughout the duration of the project. All designated subcontractors will also be required to have current and active CSLB licenses at the time of submission of the bid and throughout the duration of the project.

Department of Industrial Relations (DIR) Registration Contractors / Subcontractors: Pursuant to Labor Code §1725.5, each Contractor and all subcontractors identified in a Contractor's subcontractors' list, submitting a proposal to complete the work, labor, materials and/or services must be a Department of Industrial Relations Registered Contractor. A bidder who is not a DIR Registered Contractor when submitting a proposal for the work is deemed "not qualified" and the proposal of such a bidder will be rejected for non-responsiveness. Bid Security Required: A bid bond in an amount not less than 10% of your bid amount must be submitted along with your bid submission.

Prevailing Wage Monitoring & Enforcement: Pursuant to California Labor Code §1771.4(a)(4) the work is subject to payment of Prevailing Wage Rates. Every Contractor and all Subcontractors of every tier, performing any portion of the work, shall pay laborers not less than the Prevailing Wage Rate established for the labor provided.
