I. ANSWERS TO PRE-BID INQUIRES

- Q: Who will provide point of connection for firewater, non-potable water, and domestic water?
 A: Contractor will provide coordination with all new utilities for service.
- **Q:** What is the construction management software for the project?**A:** Procore.
- **3. Q**: Sewer line at softball field shown on sheet C1.05 shows to remove portions of the existing 10" sewer pipe. The build out of new sewer line is conflicting with the demolitions design. Please clarify. The utility plan sheet C.4.05, depicts two routes for the new sewer connection; provide actual demolition information as relates to the building out plan and show the preferred connection of new sewer line.

A: C4.05 does not show two routes for the new sewer. It shows the reroute of a 12" sewer and laterals to the new buildings. As part of Addendum 3, lateral to building Y2 has been revised to 4" from 12". C1.05 does not appear to be in conflict.

4. Q: Do you require an equipment entrance at beach Volleyball at parking lot, if so will there be a need to increase thickness of adjacent concrete sidewalk?
A: See Addendum 2 for architectural response and Addendum 3 for C3.03 revisions to provide 0"

A: See Addendum 2 for architectural response and Addendum 3 for C3.03 revisions to provide 0" curb at this location.

- 5. Q: Will the alternate #1 be omitted from plans?A: Yes, all references to alternate #1 will be omitted.
- 6. Q: Can the domestic and irrigation water connections be closer to building W2 on Faculty Way?A: *No change to domestic water and irrigation routing proposed.*
- 7. Q: Will the Civil engineer be providing a precise grading plan?A: See sheets C3.00-C3.05 in approved plans.
- Q: Please provide an Architectural detail for the Telescoping Monorail System specified in the Specification sections 14 6500.
 A: Information added in Addendum 3.
- **9. Q:** Please confirm if the referenced paragraph is correct in requiring domestic materials only. If intended, this requirement make material acquisition very difficult for certain sizes and may not be available at all. This will certainly make it necessary to schedule for long lead times on mill runs and will increase the likelihood of delays due to material non-availability at the time of order. We would suggest allowing material available at the time of ordering whether domestic or foreign if it is possible.

A: Domestically fabricated in United States of America (USA) for welded pieces. Revised Section 05 1200 is issued with Addendum 3. NOTE: Performance of Welding in USA is mandatory per DSA.

10. Q: Please confirm there is not a requirement for the General Contractor and Pool Subcontractor to formally commit and name each other as a team as part of the prequalification process. A prequalified General Contractor should be eligible to list any prequalified Pool Subcontractor based on the competitive bid process on bid day and list the Pool Subcontractor as required per public code.

A: Confirmed. There is no requirement for the Pre-Qualified General Contractor and the Pre-Qualified Pool Subcontractor to formally commit as a team.

11. Q: The temporary facilities and controls spec. section 015000-1.02 indicates all temp utility use charges to be paid by the GC. It was discussed at both job walks that there would be clarifications issued by the district regarding point of connection locations for each service and if any services would be actually paid by the District. Please provide point of connection for power, sewer etc. and clarify if any of these services will be paid by the district.

A: *The General Contractor will be required to provide all temporary utilities for the duration of the project. The District will not be paying for any temporary utilities.*

12. Q: The bid proposal form (spec section 00 42 00) identifies a \$530,000 allowance to be included in the base bid. The allowance specification section 01 21 00 identifies at \$50,000 allowance to be included in the base bid. Please clarify the required allowance to be included in the base bid amount and confirm the structure of what tis included in the allowance amount (materials, labor, contractor's overhead & profit) is per the allowance spec section 012100.

A: The allowance for this project is \$530,000.00. The allowance structure is as follows: \$500,000.00 is for unforeseen conditions and & 30,000.00 is for permit reimbursement for utility tie-in.

- 13. Q: Please confirm the "Attachment A- Composite Unit Price Bid Proposal" is not applicable to this project and therefore not required to be submitted as part of the bid package.A: Confirmed, Composite Unit Price Bid Proposal is not applicable.
- 14. Q: Please confirm the "Blind Bid Proposal" is not applicable to this project and therefore not required to be submitted as part of the bid package.A: Confirmed, the Blind Bid Proposal is not applicable.
- 15. Q: Please advise if the Certificate of Workers Compensation Insurance and Drug Free Workplace Certification forms need to be submitted with the bid package.
 A: The Certificate of Workers' Compensation Insurance and Drug Free Workplace Certification forms are required to be submitted with the bid package.
- **16. Q:** Please advise if the "Roof Project Financial Disclosure Certificate" and the "Verification of Certified payroll Records Submittal to Labor Commissioner" forms are not required to be part of the bid package.
 - A: The Roof Project Financial Disclosure Certificate and the Verification of Certified Payroll Records Submittal to Labor Commissioner forms <u>are required</u> as part of the bid package.
- 17. Q: Please provide specifications for the fabric shade structures identified with the Alternates specification 012300.
 A: Refer to the project documents plan number PC. T-1.0 for typical Fabric Shade Structures.
- **18. Q:** Confirm double shades at room W201 per W-A202 and 1/A8531 are type 2 motorized per spec. **A:** *Correct, see Addendum 3 for further information.*
- 19. Q: Confirm rooms W132 & W148 do not receive shades.A: *These rooms require shades. See Addendum 3 for further information.*
- 20. Q: Special Conditions section 17.22 describes the procedure of OFCI items. Please provide a list of an OFCI items that need to be included in the bid.A: Review the project plan set for the equipment legend for OFCI items, on sheet A813.
- 21. Q: Please refer to the Pump System per Pg C4.04 note 29 and detail 3 per C9.02. Please confirm that the pump hosepower/discharge capacity is correct. It seems rather big in comparison to the 4" outlet and 8" pipe to the curb. Furthermore, Pg C4.04 shows a 4" outlet and a 14 outlet, which conflicts with the 8", provided in the detail.

A: See storm drain/pump system clarifications provided in Addendum 3.

- 22. Q: Will the power to the parking lot lights of parking lot M need to be restored to remaining lights post after demolition of light poles to be removed?A: Yes. See Addendum 3.
- 23. Q: Will the cabling subcontractor be responsible for demo of any existing cabling? If so, what cabling and where is it located?A: *Yes, see 'D'*.

- 24. Q: The specification refers to six different finishes for cable runway ladder. Which finish will be required on this project?A: White. See Addendum 3.
- 25. Q: AXIS indicates the specified P3707-PE camera has been discontinued. Is the AXIS-recommended P3717-PLE replacement camera acceptable?A: Yes, that is the correct replacement.
- **26. Q**: General note 42 on T001 states in part that contractor is responsible for installation of the phones. Please provide task details and item quantities for the phone installation required by this plan note.

A: The College has decided to place instruments, remove from scope. See Addendum 3 for clarification.

27. Q: How many SM and OM3 fiber strands are required from the location indicated by the note 9 symbol to the Building T MDF on T101?

A: The contractor is responsible to provide, terminate, and test (48) strands of OS2 and (24) strands of OM4 all to be Corning OSP cable with Altos glass.

28. Q: What and where are the "main campus cores" that note 7 on T101 refers to? Is this a reference to the core fiber distribution emanating from the Building T MDF?

A: The "Main Campus Cores" refers to LBCC Network Cores that are the responsibility of the LBCC Network Team. Contractor is responsible for a turn-key low-voltage/signal pathway and category 6A cabling solution that meets manufacturer's extended warranty.

29. Q: Is there a manufacturer and model number or other specification for the "Modified Traffic Cabinet" called for in note 3 on T101?

A: Detail #5/T601 is an American Standard Cabinet – an or "approved" equal will be accepted. Cabinets shall be required to include all racking hardware, 120V-AC power, manufacturer's ventilation system, optical fiber terminations, category 6 OSP termination.

- 30. Q: What is the physical location where the cables are to be pulled back and protected in place per note 4 on T101D.
 A: As note "At" CMH-#15
- **31. Q:** Corresponding plan note symbols do not appear for notes 1-5 on T103. Please provide drawing on which plan notes 1 through 5 appear.

A: Notes will be updated on T103 that shown end devices on Y-T201. Notes 1-3 are for roof/OSP infrastructure. Notes 4-5 are IDF notes for the Y1 build CPCI turn-key IDF cabinet. Contractor is responsible for all roof and build attachment from a complete low-voltage/signal outside plant conduit and OSP Category 6A cabling solution for end devices.

32. Q: What is the manufacturer and model number of the enclosure referenced in note 5 on T502?
A: Wall mounted Corning with Patch Cords to feed network connections is acceptable if there is not room inside the cabinet. If there are (design shows) a CCH-1RU is the correct part-number. All optical fiber shall be Corning all termination shall be Corning and inside Corning CCH housing. This is District standard optical fiber solution that shall require the contractor to provide the Corning-certified extended warranty.

33. Q: What is the model number of the Aruba wireless access point and its associated mounting arm per note 10 on T502? These items appear to be different than the Aruba items reference on Plan Sheet T607 Caption 2.

A: T607/#2 is the Correct Aruba-275 w/ AP270MNT-HI Mount Arm.

34. Q: What is the manufacturer and model number of the broadcast camera that the contractor must install that is referenced per note 14 on T502?

A: AV End devices are listed in TAV-drawing sheets—references will be added to correct TAV sheet.

35. Q: What is the manufacturer and model number of the broadcast speaker that the contractor must install that is referenced in per note 16 on T502?

A: AV End devices are listed in TAV-drawing sheets-references will be added to correct TAV sheet.

36. Q: What is the model number of the Oberon enclosure to be used at the location indicated by this symbol per note 3 on W-T201.2, W-T202.1, W-T202.2, and W-T203?

A: Oberon enclosure has been removed from design – OPCI Access points shall be installed per detail #3/T602. Contractor shall provide adapter for backbox attachment to OPCI WAP. Wireless Access point outlets-locations shall be a 4S back-box with an 1-1/4IN conduit extended to accessible cable tray or home run to the IDF that includes (2) CAT6A CMP Cables. This is different then the standard "work area outlet" that is a 5S back-box supported by a 1-1/4IN conduit with a single gang mud ring, with a 4-port faceplate w/ blanks in unused ports, cable shall be (2) category 6A CMP cables.

37. Q: Detail 3 per T503 appears to illustrate 156 OS2 fiber strands to be fusion spliced to a 72 fiber cable. Is this intentional in that only 72 of the fiber strands are to be fusion spliced to the cable routing to the MDF?

A: All strands are to be terminated on APC-LC connectors in CCH modules in CCH housings are each termination locations – Detail also shows Contractor provided optical fiber patch cords quantity and lengths.

38. Q: Note 4 per detail 1 indicates that a 110 block is to be provided. This bidder's understanding is that 10-Pair Type 2 blocks are the campus standard for copper backbone cabling. Please confirm or correct.

A: Current District standard is 110 termination for 24-AWG UTP backbone cabling.

- **39. Q:** Please provide soils report.
 - **A:** *Refer to soils report provided by Koury Engineering dated November 13, 2017 per Attachment G of original bid documents.*
- **40. Q:** Please provide an abatement survey as applicable to the structure demo.
 - **A:** *Refer to Hazardous Building Material Survey report provided by Ninyo & Moore dated April* 10, 2018 per Attachment Q of original bid documents.

- 41. Q: To whom is the CSWPA Letter of Assent to be addressed? Is it Robert Rapoza as listed on Page 2 of Attachment J-02 CSWPA AMENDMENT?
 A: Please address Letter of Assent to Robert Rapoza, Director, Business Support Services.
- 42. Q: Please refer to Specification Section 11 6843 Exterior Scoreboards 1.01 A.2. Work to be performed by scoreboard installation contractor under separate CMAS contract. Are all scoreboards are both furnished and installed by owner?
 A: Yes.
- **43. Q:** Please refer to sheet W-P102 & sheet C4.03. The drinking fountain for the Volleyball Court located at the SW corner does not appear to have a sanitary sewer point of connection (POC). Please clarify

A: See Addendum 3 C4.03 and C4.04 for water/sewer connections to serve drinking fountains. C4.03 fountain will discharge to dry well per plumbing in Addendum 3 revisions.

- 44. Q: Please refer to sheet W-P201.3. The exterior showers for buildings W-1 and W-2 indicate cold water only. Please confirm this is the intent.A: Correct.
- **45. Q:** This project's Notice to Bid document states that all bidders and subcontractors will be required to have an active California Contractor's License of Class A or B at time of bid. Are class C licenses acceptable for specialty trades (e.g. C-7 for Low Voltage Systems)?
 - **A:** The project's requirement for a California Contractor's License of Class A or B is a requirement for pre-qualified General Contractors bidding on this project. Subcontractors will be required to have the appropriate CSLB license.
- 46. Q: Please confirm if subcontractors are required to complete the District's Pre-Qualification Questionnaire, or if this is only a requirement for those turning in bids directly to LBCC.A: Subcontractors are not required to complete the District's Pre-Qualification Questionnaire.
- 47. Q: On the demolition plan C1.05 has a note #19 that states light/pole/footing, salvage LED lamps and poles. There appears to be five (5) light poles show on the plan with no reference to note #19. Are the light poles to be removed?A: See addendum Sheet C1.05 indicate removals.
- 48. Q: Are gates GW20 and GW21 intended to be dual emergency egress gates? If not, which path is the designated path of egress?A: Yes.
- 49. Q: Per spec 07 52 16, what is the thickness of the polyiso insulation on the flat roof areas?A: *Thickness is not indicated. R value is R-30 per specifications.*
- 50. Q: Per spec 07 32 16, what is the sheathing type attached to the steel structure on the pitched roofs for the concrete tile roofs?A: *Plywood sheathing as specified in Section 06 1053.*

- 51. Q: Will you accept polyfoam adhesive and an alternative for installing the roof tiles in lieu of battens or wire tie system?A: No.
- 52. Q: The spec book contains specs 220800 Commissioning of Plumbing, 221619 Disinfection of Potable Water Systems, 223300 Electric Domestic Water Heaters, 232500 HVAC Water Treatment but they are not listed in the table of contents. Please clarify.
 A: Revised Table of Contents is issued with Addendum 3.
- 53. Q: Specs 221123 Domestic Water Packaged Booster Pumps, 221329 Sanitary Sewerage Pumps, 221429 Sump Pumps, 261200 MV Transformers, 261213 Liquid Filled MV Transformers, 261216 Dry-Type MV Transformers are listed in the table of contents but it was not found in the spec book. Please clarify.
 A: Revised Table of Contents is issued with Addendum 3.
- 54. Q: Spec 321726 Tactile Warning Surfacing, page 4 is blank but the spec continues on page 5. Please provide page 4 of this spec.
 A: Please omit page four (4) of 32 1726.
- **55. Q:** Detail 1 on C302 refers to SPECIFICATION SECTION 02338 regarding the pulverization of the existing asphalt 457,300 SF area indicated on drawing C202. Please note this spec section does not appear in the spec book but we need this information for clarifying the requirements of the pulverizing cement treatment process. Please provide for reference.

A: The information noted above does not exist on the plan sheets indicated nor in the project documents.

- 56. Q: Attachment B of the Bid Form currently lists Alternate Bid Item No. 1 as "Not Applicable". Spec 012300 Alternates indicates there is an Alternate #1 for safety netting. Please clarify. A: Alternate Bid #1 in Spec 012300 will be removed in Addendum 3.
- 57. Q: Please clarify where spec section 105613 Metal Storage Shelving applies to the project. A: Shown on SKA-66 and SKA-67.
- **58. Q:** Please confirm the existing headend software/PACS used by LBCC and the District. **A:** *The existing headend software/PACS used by the District is Insight.*
- 59. Q: May contractor bidding 28 13 00 Physical Access Control include the required Omni-lock components in their proposal?A: General Contractor responsible for all access control components.
- 60. Q: The shade canopy shown at detail 9/A015 is not listed as being an Alternate. Is this particular canopy to be included in the base bid?A: Yes.
- 61. Q: Please clarify where spec section 146500 Telescoping Monorail System applies to the project.A: *It is located in Building W2, Room W143. See Pool Drawings.*

- **62. Q:** Please clarify where spec section 071813 Pedestrian Traffic Coatings applies to the project. **A:** *Refer to Article 1.01, Paragraph A:*
 - A. Section Includes:
 - 1. Fluid applied, High Solids, Low VOC, waterproof, pedestrian traffic coating on concrete stair fill at metal stairs.
- 63. Q: Drawing A003, brick paving is indicated at the top of this drawing. Please provide a detail for this brick paving as well as a specification.A: Please see C3.05 Grading Plan Addendum 03.
- 64. Q: Regarding the color schedule on A704, spec 033000 Cast in Place Concrete designation CPC-2 indicates Davis-Precast Colored Concrete at column and handrail caps. There is no indication in this spec regarding Davis Precast. Please clarify if the spec section that should be listed on the finish schedule for precast is 034800 Precast Concrete Specialties. Please note that this precast spec lists the manufacturer as Aristone.
 A: Please refer to SKA-76.
- **65. Q:** Regarding the finish schedule on A703.1, the Floor/Base legend contains AWF, Athletic Wood Floor System. This system was not indicated to be used at any rooms listed on the finish schedule. Please confirm this system does not apply to the project.

A: Not every item in the Finish Abbreviation List is used in the project. Follow actual Finish Schedule for materials.

- 66. Q: Regarding the color schedule on A704, spec 066000 Plastic Fabrications lists 3-From as a manufacturer. There is no indication in this spec of 3-Form being the manufacturer. Please clarify. A: For manufacturer listing, see Spec Section 06 6000, Article 2.02A, 3a.
- 67. Q: Regarding the color schedule on A704, spec 084113 Aluminum Entrances and Storefronts lists a PPG Durandar Sunstorm Coating. There is no indication in this spec of this type of coating. The spec lists to use a high-performance coating system per spec 050513. Please clarify.
 A: Section 05 0513 specifies the PPG Duranar coatings for extruded aluminum. See revision in Addendum 3.
- 68. Q: Regarding the color schedule on A704, spec 096500 Resilient Flooring designation RF-3 indicates Johnsonite-Replay Fusion rubber flooring. This manufacturer is only listed as a rubber wall base and not a rubber flooring. Please clarify.
 A: Section 09 8500 specifies RF-3 as Resilient Athletic Flooring by Mondo. See revision in Addendum 3.
- 69. Q: Regarding the color schedule on A704, spec 105129 Phenolic Lockers indicates the manufacturer as Bobrick. The spec lists the manufacturer as Titan Laminate Lockers by Alan Lewis. Please clarify.
 A: Please see SKA-76.
- **70. Q:** Article 4.4.4 on pages 83 and 84 of the General Conditions specify Contractor's staff. Please clarify if the Assistant Superintendent as specified in article 4.4.4.2.1 is required to be at the Site continuously like the Assistant PM is required to be per 4.4.4.3.1.

- **A:** The General Contractor is responsible to have a competent person supervision on-site at all times during the course of construction activities.
- 71. Q: Does the District have an approved vendor (and "or equal") for the text and logo to be used on the site perimeter fencing as specified in article 17.9 on page 145 of the Special Conditions?A: *No, District will provide artwork for awarding contractor.*
- 72. Q: We respectfully request that an allowance be added to the project for the cost of the deferred approval submittals, sewer, water, storm drain and gas tie-in plan check permits, fire and domestic water and City of Long Beach encroachment permits all of which are currently indicated to be included in the Contract Price per article 17.39 on page 153 of the Special Conditions.
 A: No allowance will be added for deferred approval submittals.
- 73. Q: The note at the bottom of "demolition notes" on C1.01 C1.05 state "…contractor to provide unit pricing." Please confirm this statement is accurate and if the unit prices are to be submitted with the bid, please provide additional information on specifics.
 A: Contractor to provide unit pricing for pavement and base removals beyond the depths assumed in the demolition notes.
- 74. Q: Is it possible to consolidate the demolition plans in the Civil set with the D001 series drawings to avoid any confusion between the two?A: Drawings will remain as separate plans.
- **75. Q:** Concrete Pavers are listed on A704 (manufacturer Acer Stone) and reference section 321313. Should the text have been "Acker" as opposed to "Acer"? Also, section 321313 is site concrete and doesn't specify concrete pavers. Please clarify.

A: Section 32 1313 is for Concrete Paving and not "site concrete" Site Concrete work is specified under Section 32 0523 – Concrete for Exterior Improvements and includes concrete work not specified in Section 03 3000 or Section 32 1313. Will provide Paver specification in Addendum 03.

- 76. Q: Please confirm that the intent of detail 2, 5, 9, 12 & 13 / A833 for waterproofing is section 07 1416.
 A: Correct.
- 77. Q: Please confirm what the head-end VMS is currently at LBCC. Will this standard remain in place for this project?A: *Current VMS system(s) are to stay in service at this time and will be extended to project facility.*
- 78. Q: Is the security contractor expected to provide a video storage solution for the new cameras? If yes, what are LBCC/District standards for video retention, including frame rate, resolution, streams, encoding, etc.?

A: These items will be owner-furnish, owner-installed.

79. Q: Does the security contractor need to provide POE and/or any other network equipment for video surveillance. If yes, please share LBCC/District standards for such.A: These items will be owner-furnish, owner-installed.

- 80. Q: Article 17.53 on page 157 of the Special Conditions states that Attachment K overrides any extra or attic stock material listed in specification sections. Please confirm that therefore, Attachment K prevails over the requirements in the technical specifications, however Attachment K is not in addition to any attic stock requirement specified in the technical specifications.
 A: Confirmed. Attachment K supersedes the requirements in the technical specifications.
- **81. Q:** Attachment C states the facility provided by the contractor must include 1 IOR office however it goes on to also state provide dedicated individual office spaces for 2 IORs. Please clarify which is correct.

A: One (1) IOR office space is required.

82. Q: Please provide quantities of office furnishings and equipment required to be provided by the Contractor for use by the Owner. The information in Attachment C is vague as it relates to quantities.

A: Provide two offices for District Construction Management staff.

- **83. Q:** Attachment O states Phase 3 starts after completion of Phase 2. However, Attachment D states milestone 7 (Phase 3) shall be substantially completed within 45 days of the effected date of the NTP. Please clarify.
 - A: Phase 3 starts after substantial completion of Phase 2, or as coordinated with BMT/LBCC based on event calendars. Removal of temporary construction fencing and barricades and final striping of parking lot M to be completed in phase 3.
- **84. Q:** If there is only one critical path for the project, how can each Phases 1, 2 & 3 each have separate rain day allowances as stated on page 149 of the Special Conditions? Phases 2 and 3 are completed prior to the completion of Phase 1 so it appears the rain days are doubled up. Shouldn't there just be specified rain days per month? Please clarify.

A: Rain days remain as indicated in the special conditions of the bid documents.

- **85. Q:** The contract duration is specified as 530 calendar days to Substantial Completion. Milestone 8 is completed 30 days after Substantial Completion of Milestone 5. Therefore, Milestone 11 shall be achieved at the completion of Milestone 8 (as opposed to Milestone 10). Does the Owner desire to have the facilities provided by the Contractor pursuant to Attachment C through completion of Milestone 11? If so, shouldn't the contract duration be 560 calendar days through Final Completion?
 - **A:** Confirmed. Include milestone 11 to project duration. Facilities to be provided throughout the duration of the project.
- 86. Q: Please provide a copy of OCIP Exhibit B as referred to on page 190 of the Special Conditions Attachment I.A: *The Attachment is included in the Special Conditions.*
- 87. Q: Section 01 2300 specifies 3 Alternates; however, page 25 Attachment B Alternate Bid Items Proposal indicates Alternate Bid Item 1 is not applicable. Please clarify and confirm the drawings accurately depict the alternates as noted in Attachment B.
 A: Alternate Bid Item #1 is not applicable to this project.

- 88. Q: Section 07 4113 Metal Roof Panels (revised in Addendum 1) is not listed in the Table of Contents. Please advise.
 A: Revised Table of Contents is issued with Addendum 3.
- 89. Q: Section 08 7113 article 1.01A states where to provide automatic door operators. However, only 1 is listed on the door schedule on A701. Please amend the door schedule if additional door operators are required pursuant to 1.01A.
 A: Please refer to SKA-75.
- **90. Q:** Article 2.01E on page 5 of section 09 0562 states to apply the moisture vapor emission control system where concrete moisture testing indicates non-compliance with flooring manufacturer's requirement for moisture vapor emissions. Please clarify what costs the Bidder should include for section 09 0562. It is unknown what slab areas will be in non-compliance until the testing is performed. Suggestions include: 1). Requiring the Bidder to include the moisture vapor emission control systems at all slabs that receive adhesive applied floor finishes; 2). Provide an allowance for the cost of this work or 3). Require the Bidder to include no costs for section 09 0562 and issue a change order for the work.

A: *Bidder is to provide cost per square foot of material at all slabs indicated to receive adhesive applied floor finishes. Submit cost at time of Bid as Alternate No. 4.*

- 91. Q: Article 2.01 on page 4 of section 09 2400 specifies a Vapor Permeable Weather-Resistive Barrier Membrane. However, there is also a section titled 07 2726 Fluid Applied Membrane Air Barrier. Are both systems to be used at applicable plaster conditions?
 A: Yes Fluid applied membrane is applied to gypsum substrate. Weather resistive barrier is applied behind metal lath to prevent damage to air barrier.
- **92. Q:** Article 2.01C on page 4 of section 09 2400 specifies flexible flashing, however, there is also a section titled 07 6500 Flexible Flashing that states it applies to Plaster (among other work). Which section is to be used?

A: Flexible flashing as specified in section 09 2400 is to be used with plasterwork. Flexible flashing specified in section 07 6500 is for other areas over tops of walls, under metal copings, and may include plasterwork.

93. Q: Section 09 9100 Painting is not listed as a related section for 09 2400 Portland Cement Plaster. Yet, section 07 1923 Water Repellent / Graffiti-Resistant Coatings is listed as a related section. However, section 09 9100 specifies painting plaster. Please clarify the requirements for coatings over plaster.

A: *Portland Cement Plaster is to be painted as specified in Section 09 9100. Water Repellent/Graffiti-Resistant Coating is to be applied over paint.*

94. Q: What type of footings are to be assumed when demolishing the scoreboards, light poles and bleachers?

A: *Existing footing types and depths are not known. Bidding contractor is to make his best, reasonable determination based on the items being removed.*

95. Q: In regards to the Plastic Fabrications (Spec 06 6000), the Color Schedule on Sheet A704 indicates the Name Plate (Designation AR-5) located at the Records Wall shall be of Clear Color and 3/16" Thickness. In addition, the Panel (Designation AR-6) at the Records Wall shall be of

Clear Color and 1/4" Thickness. However, Details 4/A825 and 8/A825 indicates 5/16" Thick Frosted Acrylic Panel and 1/4" Thick Clear Acrylic Name Plate. There is a conflict of information regarding thickness and color. Please clarify. A: Please see revisions in Addendum 3.

96. O: The description for Detail s/A824 (Titled: "Team Room Flooring") doesn't seem to match the title of the detail. The description statement is about full-height vinyl wall graphics, and not about flooring. Please clarify.

A: See Addenda 2 reissued Sheet A824.

97. Q: Sheet A001 has several notes stating "12' Vinyl Coated Chain link Fence w/ Ball Netting above to 30' " surrounding much of the perimeters of both the Multi-Purpose Field and Soccer Field. The notes also reference Detail 6/A012 for netting details. However, Detail 6/A012 shows 11'-6" of fence at Soccer/MP Field. The aforementioned Detail conflicts the information shown on Sheet A001. Please clarify.

A: Fencing height is 12'-0"; the starting of the netting starts at 11'-6". This is not in conflict. However, offsetting of both system will be addressed in Addenda 3.

- **98. Q:** The Equipment Schedule on Sheet A813 does not list Edge Guard under the Sand Volleyball equipment section. Edge Guard is listed in Spec Section 11 6833. Are Edge Guards to be C.F.C.I.? A: Yes.
- **99. Q:** The Equipment Schedule on Sheet A813 under the Athletic Training Center Section lists the Whirlpool to be 96 gallons and the Extremity Whirlpool to be 35 gallons. However, in Spec Section 11 6600 it lists the Lo-Boy Whirlpool to be 105 gallons and the Extremity Whirlpool to be 27 gallons. Please clarify.

A: Follow Equipment Schedule in drawings.

- **100. O**: The Equipment Schedule on Sheet A813 under the Athletic Training Center Section lists the Taping Table to have 2-seats. However, in Spec Section 11 6600 it lists the Taping Table to be a Three Seat Station. Please clarify. A: Follow Equipment Schedule in drawings.
- 101. Q: Spec Section 11 6600 lists the Upper Body equipment, Monark 871 E Arm/Leg Trainer. However, the Equipment Schedule on Sheet A813 under the Athletic Training Center Section does not list this item. Please clarify if this equipment will be C.F.C.I. A: Remove from Specifications.
- **102. O:** The Equipment Schedule on Sheet A813 under the Softball Section lists Maintenance Rake and Heavy-Duty Cover Set. However, Spec Section 11 6833 does not list the items. Please provide Spec information on the said items. A: This is provided by CMAS agreement.
- **103. Q:** Spec Section 11 6833 lists the following items for the softball field: Foul Poles, Helmet Cubb and Coat Rack Wall Unit, Storage Base Unit, and Wall-Mounted Bat Rack. However, the Equipment Schedule on Sheet A813 do not list the items. Please clarify if these items will be C.F.C.I.

A: *These items are to be provided and installed by the Contractor.*

- 104. Q: The Equipment Schedule on Sheet A813 under the Aquatics Section lists multiple items that will be C.F.C.I. However, Spec Section 11 6833 does not mention any of these items. Please provide Spec Information regarding these items.A: *This is to be provided by the Pool Contractor.*
- 105. Q: The Equipment Schedule on A813 under the Tennis Section does not list any tennis items listed under Section 11 6833. Please clarify.A: Per specifications, equipment to be provided and installed by the Contractor.
- 106. Q: Y-TAV201 illustrates AV equipment in the Home Softball Team Room Y-119. Specification 274116 quantified equipment list and the TAV series schematic line drawings do not indicate any equipment in room Y-119. If this equipment is required, please provide all makes and model numbers for the required equipment with updated schematic line drawings to reflect connectivity. A: See drawing Y-TAV302 for AV infrastructure requirements. All displays will be furnished and installed by the District. Contractor is to provide backing, E.C. to install back box and power, telecom contractor to add data drop. AV equipment is owner-furnished and owner-installed unless otherwise indicated. Contractor to install ceiling speakers only. Equipment list for <u>all</u> team rooms in in specifications section 274116 page 12, room number had been changed in drawings not in specifications.
- 107. Q: Y-TAV201 illustrates AV equipment in the Y-116 locker room. Specification 274116 quantified equipment list and the TAV series schematic line drawings do not indicate any equipment in room Y-116. If this equipment is required, please provide all makes and model numbers for the required equipment with updated schematic line drawings to reflect connectivity. A: No AV equipment in Locker rooms, only team rooms.
- **108. Q:** TAV101 illustrates infrastructure to be provided and installed for future use. Please clarify what trade owns this matrix.

A: *Infrastructure to be provided in the construction project, only the owner-furnished/installed. cameras/equipment indicated will be for future use.*

109. Q: Specification 274116 indicates six (6) PTZ cameras to be installed on the soccer and lacrosse fields. AV101 only illustrates two (2) cameras to be installed. TAV101 also illustrates three (3) cameras to be installed in building W. Schematic line drawings do not illustrate a system in building W. Please clarify how many cameras are required. Please clarify if building W is part of the Soccer and lacrosse system. If it is not part of that system, please provide updated schematic line drawings to show connectivity.

A: Provided per drawings. Cameras on building 'W' and score board are to be provided, the remaining cameras are infrastructure now.

110. Q: TAV101 illustrates type S2 speakers and type S3 speakers. Specification 274116 indicates speaker types SPKR1-1 to SPKR1-4 and SPKR2-1 to SPKR2-X. These speaker types do not match. There appears to be a discrepancy on speaker counts for both types as well. Please clarify what speakers are required. Please also clarify the quantity required of each type as well.
A: SPKR1-x in specifications are the S2 speakers in drawings to support the fields, SPRKR2-x in specifications are S3 speaker facing the bleachers.

111. Q: W-TAV203 illustrates a 65" flat panel display with backbox in the W-155 Lobby. Schematic line drawings do not indicate this flat panel display in any system. Please clarify if this display is required. If so please provide a make and model number of the said display. Please provide updated schematic line drawings to illustrate connectivity.

112. Q: W-TAV301 illustrates AV equipment in Team Room W-111. Specification 274116 and the TAV series schematic line drawings do not indicate any equipment in the W-111 room. Please clarify if this room is required. If so, please provide a quantified equipment list and updated schematic line drawings for the required room.

- 113. Q: W-TAV305 illustrates nine (9) ceiling mounted speakers to be installed. Specification 274116 equipment lists indicates twelve (12) speaker to be installed in the W-201 Multi-purpose Room. Please clarify the quantity of speakers required.A: Provide 9 speakers.
- 114. Q: W-TAV305 illustrates two (2) equipment racks to be installed in the AV closet. Specification 274116 indicates only one (1) rack to be installed. Please clarify how many racks are required. A: *Racks are to be owner-furnished/installed*.
- **115. Q:** W-TAV307 illustrates AV equipment in Team Room W-148. Specification 274116 and the TAV series schematic line drawings do not indicate any equipment in the W-148 room. Please clarify if this room is required. If so, please provide a quantified equipment list and updated schematic line drawings for the required room.

A: A Racks are in all Team rooms and are to be owner-furnished/installed.

116. Q: W-TAV308 illustrates a touch control panel in room W-164. Specification 274116 equipment does not list indicate a touch control panel in W-164. Please clarify if this panel is required. If so, please provide a make and model number of said touch panel and an updated schematic line drawing to reflect connectivity.

A: There is no control panel as indicated in the drawing or specification drawings calls for a MIP or media input panel.

- 117. Q: Specification 274116 and the TAV series drawings show multiple room number conflicts. Please provide an updated list of required rooms with the correct numbers with updated line drawings and updated floor/ceiling reflective plans.A: See Addendum 3 for information.
- **118. Q:** Please confirm if this project will require the use of union labor for all on-site work. **A:** *DSA projects require prevailing wage certified payroll.*

- 119. Q: Please confirm if subcontractors are required to complete the District's Pre-Qualification Questionnaire or if this is only a requirement for those turning in bids directly to LBCC.A: Only pool subcontractors are not required to complete the District's Pre-Qualification Questionnaire.
- 120. Q: Specification Section 274116 indicates four (4) Axis PTZ cameras to be supplied and installed by the AV contractor. No part number for said Axis cameras were given for the Aquatic Center system. Please provide a model number for the required PTZ cameras in the Aquatic Center. A: *Camera specifications and part numbers <u>are listed in specifications</u>.*
- 121. Q: Specification Section 274116 indicates and Extron 200 Media Link Plus controller to be provided and installed by the AV contractor. Schematic line drawing TAV505 does not illustrate a Media Link Plus Controller. Please clarify if the controller is required. If the controller is required, please update schematic line drawings to illustrate connectivity.A: Controllers are to be owner-furnished/installed.
- **122. Q:** Specification Section 274116 indicates a presenter's lectern to be supplied for each team room. No make or model number for said lecterns have been provided. Please clarify if these lecterns are OFE. If the AV contractor is to provide said lectern, please provided a make and model number for the required lecterns.
 - **A:** Lecterns are to be owner-furnished/installed. Infrastructure to be provided by General Contractor. Equipment shall be owner-furnished/installed.
- **123. Q**: Schematic line drawing TAV502 illustrates document cameras to be provided and installed by the AV contractor. Neither TAV schematic line drawings nor specification section 274116 indicate a make or model number for the document camera required. If the AV contractor is to provide said document cameras, please provide a make and model number of the required document cameras.

Please clarify if this equipment is required. If this equipment is required, please provide the makes and model numbers of all required equipment with updated schematic line drawings to illustrate connectivity. If this equipment is already listed, please provide clarification as to which system this equipment belongs.
 - **A:** AV equipment rack for field to be installed in this room and are to be O.F.O.I. Infrastructure to be provided by General Contractor. Equipment shall be Owner-Furnished Owner-Installed.
- 142. Q: Special Conditions Part 15.4, Option 3, Pg.12 Base Contract Plus Designated Alternates, Lists Alternate 2, & 3. This does not match Specification 01-2300 Alternates, Lists Alternate 1, 2, & 3. Please Advise.

- 143. Q: Special Conditions Attachment B. Alternate Bid Items Proposal Does Not Match Specification 01-2300 Alternates, Part 3, Section 3.01. Please advise.

- 144. Q: Special Conditions Contract Time: Liquidated Damages, Section 17.14.1, Part 17.14.1.4, Pg. 147, States Delayed Completion of Punch List Items in the Amount of One Thousand Dollars (\$1,000) Per Day. However, Special Conditions, Attachment D to Special Conditions, Schedule of Milestones, Pg. 162, Punch List Phase 1 through Phase 3 States Delayed Completion of Punch List Items in the Amount of Five Hundred Dollars (\$500) Per Day. Please Clarify.

A: The liquidated damages for delayed completion of punch list items is \$500 per day as indicated in the schedule of milestones of Attachment D.

A: Refer to 1.1.4 of the Special Conditions for the Bidder's price proposals for Unit Price items.

147. Q: Specification 01-0100 Construction Schedule States Two (2) Phases, & General Sheet G003 Illustrates Three (3) Phases. Please Clarify.
A: The project consists of 3 phases as indicated in the Schedule of Milestone of the Special

157. Q: As shown on F002, "all paving in fire lane is heavy duty concrete". However, drawing sheets C2.03, C2.04, C2.05, A001, and A002 show the new parking areas to receive asphalt paving (see clouded areas in attached sketches). Please clarify whether the new parking areas (clouded in attached sketches) are to receive heavy duty concrete per F002 or asphalt paving per C2.03, C2.04, C2.05, A001, and A002.

A: See Addendum 3 for clarification.

- 158. Q: Spec 329300 3.06 conflicts with plans and calls for 4" deep mulch, what is the depth of mulch required? Is filter fabric required at all planting areas?
 A: Plan Legend sheet L011 calls for 3" layer of 'Forest Floor' wood mulch while specification calls for 4" mulch. 3" layer of mulch meets State MWELO water efficiency requirements. 4" layer could be problematic with groundcovers and new small plants as well as potential for bark migration onto surrounding hardscape surfaces. Recommendation is for 3" layer of mulch. Per District approved specifications 329300 3.06 A. filter fabric is required in all planting areas.
- 159. Q: Spec 329300 3.09 calls for 1-year maintenance but typically this would be a 90-day maintenance. Please confirm 90-day maintenance is acceptable.
 A: District approved specification 329300 3.09 calls for 12 month maintenance for Trees and Shrubs and 6 month maintenance for Ground Cover and Other Plants (turf repair) to be provided by skilled employees of landscape Installer.
- 160. Q: Please refer to L003 mainline fittings. There is a discrepancy with the 4" mainline which indicates SCH 80 fittings but the note under it says Leemco fittings for Bell pipe. Please clarify.
 A: Legend callout should indicate all 4" mainline will use Leemco fittings only, not schedule 80 fittings. Correct Legend text to read: 4" WITH SCHEDULE 200 BELL AND GASKET WITH DUCTILE IRON PUSH-ON FITTINGS AND MECHANICAL JOINT RESTRAINTS.
- **161. Q:** Building Y1 Water Heater will require a floor sink for discharge piping. Current drawings do not indicate. This room does have a hub drain however it is not feasible for water heater discharge piping. Please clarify.
