Mandatory Virtual Pre-Bid Conference: A mandatory Pre-Bid Conference will be conducted virtually using Zoom on, **July 28, 2021, beginning promptly at 1:30 P.M.** All Direct Contractors planning to submit a bid are required to attend the entire pre-bid conference. Participants must join the Zoom meeting at or before **1:30 P.M.** Persons arriving later than said time will not be allowed to join the meeting, nor be allowed to bid on the project as prime contractors. License Requirements: The successful Bidders and subcontractors will be required to have current and active California Contractor's Licenses at the time of submission of the Bid: **Licenses required: B (with a Myrtha certified C-53 licensed subcontractor)**

Bid Security Required: 10% of the maximum amount of the Bid Proposal in the form of Bid Bond, Cash, or Certified or Cashier's Check.

Bonds Required: Performance and Labor & Materials 100%.
