**Informal Bidding List Prequalification (CUPCCA).** The District has adopted the California Uniform Public Construction Cost Accounting Act, per Public Contract Code 22032 for any Public Works Project's estimated to be below \$175,000. Bidders must be listed on the District's 2018 Informal Bidding Contractors List prior to bid opening. If you submit a bid without being on the list your bid will be deemed non-responsive and rejected. **Mandatory Pre-Bid Conference:** A mandatory Pre-Bid Conference will be conducted on, **April 11, 2018** beginning promptly at **10:00 a.m.** Participants shall meet at Long Beach Community College, Pacific Coast Campus, 1305 Pacific Coast Hwy, Building GG, Room 238, (Upstairs), Long Beach CA 90806. Only bidders who participate in the Conference in its entirety will be allowed to bid on the project as prime contractors. Participants must arrive at or before **10:00 a.m.** Parking is available in unmarked stalls with the purchase of a parking pass purchased at one of the kiosks. Parking passes are available for purchase at the kiosks. Persons arriving later than said time will not be allowed entrance nor be allowed to bid on the project as prime contractors. **Bonds Required:** Performance and Labor & Materials 100%.
