Mandatory Virtual Pre-Bid Conference: A mandatory Pre-Bid Conference will be conducted virtually using Zoom on, **March 10, 2021, beginning promptly at 10:00 A.M.** All Direct Contractors planning to submit a bid are required to attend the entire pre-bid conference. Participants must join the Zoom meeting at or before **10:00 A.M.** Persons arriving later than said time will not be allowed to join the meeting, nor be allowed to bid on the project as prime contractors. Zoom meeting information will be posted to the District website (<https://www.lbcc.edu/pod/current-bid-rfp-opportunities>).

(Note: Bidders should allow ample time to join the virtual meeting to avoid tardiness due to technical difficulties.)

License Requirements: The successful Bidders and subcontractors will be required to have current and active California Contractor's Licenses at the time of submission of the Bid: **Licenses required: B and C-22, or B with C-22 licensed subcontractor.**

Bid Security Required: 10% of the maximum amount of the Bid Proposal in the form of Bid Bond, Cash, or Certified or Cashier's Check.

Bonds Required: Performance and Labor & Materials 100%.

Bidding Documents: Bid Documents will be available from ARC Document Solutions, 1435 Daisy Avenue, Long Beach, CA 90813; Telephone (562) 436-9761, for a non-refundable payment per set for the cost of reproduction. A bidder who is not a DIR Registered Contractor when submitting a proposal for the work is deemed "not qualified" and the proposal of such a bidder will be rejected for non-responsiveness.
