SCOPE OF GUIDE

The purpose of this Career Guide is to provide high school and college students with an opportunity to explore careers in Global Trade in SoCal. It is designed not only for students, but also to assist teachers, counselors, and others to infuse Global Trade in their pathways and programs.

This guide is unique in that it is regional, highlights local employers, and spotlights local professionals so students see the global opportunities in their local communities.

While there are different levels of expertise required for careers in Global Trade, this guide will show you the many middle-skill positions available in the Los Angeles Region. These are jobs that require more education and training than a high school diploma, but less than a four-year college degree.

It's worth noting community college courses and programs can be an excellent entry-point, but having an associate's or bachelor's degree will also open up more possibilities in this sector, in terms of salary and opportunities for advancement.

The jobs, companies, and career spotlights highlighted in this guide represent the breadth of actual career opportunities available in the Global Trade ecosystem in Southern California. It's not an exhaustive list, but showcases many possible entry points for students.

Please note job titles can be named differently depending upon the employer. Also, some entry or mid-level jobs available may not have "global" or "international" in the title, but are still part of this industry sector.

The salary information provided is intended as a guide, and differs from company to company. Most of the salary statistics are drawn from California EDD or Federal BLS. (California EDD - California Employment Development Department, Federal BLS - US Bureau of Labor Statistics)

TIPS FOR PRIVATE SECTOR JOBS

Private businesses offer the most employment opportunities in the international arena. As the global economy continues to develop and nations become more interdependent, international business operations will expand accordingly. The following pages present a sampling of career options. Demands for these positions will fluctuate and new possibilities will open as international business expands and it becomes easier, and necessary, to go global.

JOB TIPS

- Companies generally categorize roles as business development, operations and customs, and freight forwarding with entry-level opportunities in each area.
- Most positions do not have "global" or "international" in the title, but are within global firms or owned by foreign subsidiaries. Names of positions may differ as well, but the functions are similar.
- Global competencies such as cross-cultural communication and languages give an advantage in this sector.
- Companies, particularly in the International Trade sector, value experience and technical knowledge. Gaining hands-on experience through internships and networking is recommended.
- · Seasonal jobs, entry/clerk, or associate-level positions in the industry are beneficial.
- Smaller companies are more flexible with education requirements, and provide a great way to get started working in the Global Trade sector.
- There are search firms dedicated to the trade and logistics industry, so make sure you include them in your job search.
- Be open to enter the market at an entry level such as clerk, associate, or customer service position.
- Position to help build your resume and showcase experience in the sector. Once you
 enter, there is a lot of room for growth.

SALES & PROCUREMENT

International sales and procurement professionals book orders for individual customers, coordinate sales through foreign distributors, or make purchases from foreign suppliers. Sales managers and representatives identify prospective buyers, present the company's product or service, and close orders. They negotiate prices, payment terms, and delivery conditions within the framework of company policy. They may also coordinate the preparation of bids for competitive procurements from government or corporate customers and provide a liaison for ensuring that customers' needs are met.

KEY SKILLS:

- Strong customer service, analytical skills, confidence in decision-making and in recommending solutions, maintain control under pressure.
- Strong interpersonal and writing skills, a good understanding of the business culture in your target market, as well as negotiation and sales skills.
- Developing proficiency in a foreign language and culture is helpful.
- Technical Knowledge: CRM for international sales, import/export compliance, tariff classification under harmonized system, developing an export plan, etc.

CAREER SPOTLIGHT

DANIEL SMELTZER **Global Sales Director, Pegasus Logistics Group**

Do you dream about a career where you'd be working with different people, and no day is guite the same as the last? For Daniel Smeltzer, Global Sales Director at Pegasus Logistics Group, that's his reality.

After attending a career fair at his school, he landed his first job working in a warehouse shipping iPod cases, his first introduction to the world of global logistics. While schooling helped him excel in these roles, his post-graduation jobs helped him focus on building strong relationships with his customer base, developing razor-sharp critical thinking skills, and understanding the value of being a dependable team member which has helped him become successful in this industry. Now Daniel oversees the import, export, and foreign logistics of millions of dollars of merchandise from Italy, Germany, Spain, the UK, and Hong Kong to name a few. The foreign logistic services can include air and ocean freight, warehousing services and customs brokerage, and advisory services.

Daniel recommends strong customer service skills, being overly polite and respectful, and having the ability to nurture relationships to stand out. When working with global clients, being knowledgeable about their business needs can create new opportunities to build business partnerships. Understanding cultural differences, accommodating time differences, and strong communication skills won't hurt you either. And with a career like this, you can always expect to be learning new skills.



GLOBAL MARKETING

Marketing is one of the broadest fields, covering the design and development of a product throughout its evolution into the market. As the globalization of markets continues, businesses need to stay current with trends that impact their ability to sell products and services. An enormous amount of specialized information is needed to make good decisions about product design, packaging, promotion, distribution, pricing, and sales techniques in each country.

As an international marketing professional, you will provide this information to facilitate entry into foreign markets. You must be able to identify economic, political, social, and demographic trends within each targeted country, and the implications of these trends for your firm's existing and future marketing strategies.

CAREER SPOTLIGHT

RITA LEGRO

Program Manager, Amazon

San Pedro native Rita Legro went from imagining herself doing presentations in boardrooms to driving multi-million dollar launches. And the supply chain allowed her to get her foot in the door.

She began her journey as an intern in Washington D.C. to learn about U.S. and China bilateral relationships, and worked as an administrative assistant at Exemplis Corporation. After being transparent with her bosses about wanting to move up, she was promoted to the role of "buyer," which is someone who possesses knowledge of current markets to get the best deal for a product from a supply chain company. During this time, Rita pushed herself out of her comfort zone, went above and beyond, and found herself researching manufacturing terms in Spanish to be able to better communicate with suppliers in Mexico to source different products and obtain good deals. This position allowed her to gain international exposure and further develop her people and negotiation skills.

Now Rita works for Amazon as a Program Manager on behalf of the manufacturers who need to interface with Amazon's internal supply chain. Rita's favorite thing about working for Amazon is the fast-paced environment and high level of employee engagement. She enjoys the fact that she's been given the flexibility to do what she thinks is best for the company.

Interested in working in a similar role? Rita suggests while Amazon or smaller start-ups may not place as much importance on a traditional four-year college degree, they do care about the value you can bring through experience. Once you get started at a company, maintaining a career and moving up in supply chain management seems more than plausible. Many companies are seeking problem-solving, team players to take them to the next level.

GLOBAL SUPPLY CHAIN & LOGISTICS


As the global marketplace continues to grow in terms of speed and access, reliability of transportation services to deliver products across the world becomes increasingly important. Logistics encompasses everything dealing with transport and operations of goods and services.

Global logistics professionals will integrate the services available from individual insurance agents, customs brokers, forwarding agents, and transportation carriers. Each of these career opportunities counts on a specific set of skills and an in-depth knowledge of every step of the transportation process. This work requires detailed familiarity with insurance, transportation, and customs terminology, as well as all related documentation requirements.

KEY SKILLS:

- Strong interpersonal skills, detail-oriented, good memory, strong math skills.
- Knowledge of company policies related to shipping and • import/export.
- Data entry, systems analysis, and knowledge of principles and • methods for moving people/goods by air, rail, sea, or road, including the relative costs and benefits.
- Ability to work independently and multitask, sense of urgency.
- Technical knowledge such as IncoTerms, trade documentation requirements, tariff classifications under harmonized codes.


SUN KIM

What started off as summer work to help pay off his student loans, became a career for Sun Kim. He is now the West Coast Director of Operations for Alba Wheels Up International, a freight forwarder and customs brokerage firm.

One of the many reasons Sun loves his career and the industry, is he feels continuously challenged and his work is ever-evolving. There's unlimited potential for an upwards career trajectory with multiple opportunities to explore other fields within logistics such as freight forwarding, customs brokerage, warehousing, and many more.

Early on as a customs broker, Sun spent much of his time learning about the industry and the best ways to navigate it. In his current role, Sun finds it's about learning the intricacies behind the work such as trade policy, meeting with heads of government agencies, and representing the trade community to government leaders and politicians. A lot of Sun's acquired experience came from learning while on the job. However, early in his career, Sun took advantage of the customs courses and seminars offered by The Los Angeles Customs Brokers and Freight Forwarders Association (LACBFFA). Through these sessions, he was empowered not only with new knowledge, but was able to refine existing knowledge.





TRADE FINANCE

Expanding trade activity around the world has increased the need for investment, credit, and general business analysts. As companies expand into new markets, the need for more sophisticated risk analysis and credit insurance will grow. Likewise, business is increasing for brokers who provide insurance against damage during transit and other risks associated with physically moving goods around the world.

Finance professionals prepare financial reports, direct investment activities, and implement cash management strategies. Strong candidates for these roles will have a background in finance or business, and a deep understanding of foreign economic environments.

KEY SKILLS:

- Ability to analyze and quantify risk, and assess complex data and provide solutions.
- Understanding and awareness of foreign and domestic developments.
- Microsoft Excel, proficiency with math, analytical mindset.
- Customer service skills dealing with clients, language is a plus.
- Technical knowledge: open account, letters of credit, filing of an EEI, IncoTerms, mitigating credit risk, export guote and pricing, import/export basics, shipping insurance.

David Josephson Senior Vice President/Director Export FinanceDavid Josephson began his career in international banking first in trade finance, international correspondent banking, and cross-border corporate lending at U.S. banks' international divisions based in the USA; London, England; South America, and Asia. Then, he worked in international merchant banking providing debt, equity, and trade/technology transfer opportunities to companies in South America wishing to break into the USA and other mega markets as suppliers and traders. For the next seventeen years he led a team of eight people in trade finance development at the Export Import Bank of the United States before retiring and returning to the private sector as a banker.

Josephson says his love of foreign languages and cultures has helped him be successful, as well as his curiosity about getting to the root and bottom of an international financial transaction and gaining trust with financial and industrial operators in other countries. It's important to have a willingness to work hard and persist as well.

He gives this advice to those seeking a career in this field: "Decide if you want to work with the best. If so, find a job in New York, Tokyo, London, Hong Kong, or Sao Paulo, and learn from the best. If you want to stay close to home, find the companies that have a global view, sharpen your skills with continued education, and relentlessly pursue them to hire you. There will always be an international business emphasis in the business communities. Banking, insurance, medical technology, IT, law, environmental technology, and equipment are filled with opportunities to do business in a global arena."

GLOBAL E-COMMERCE

Electronic commerce, or e-commerce, refers to business transactions that are managed and operated online and on mobile devices. Cross-border e-commerce has allowed businesses worldwide to set up virtual shops, increasing their consumer base on an international scale. It has also facilitated the operations for entrepreneurs who, through their computers and tablets, can run multi-million-dollar businesses without ever leaving their house. For consumers, e-commerce has completely transformed the shopping experience. The most powerful examples being retail giants Amazon and Alibaba Group. Tens of millions of customers count on global marketplaces to fulfill their needs from books to electronics and household items to groceries.

- Technical knowledge in SEO, website globalization, and social media marketing.







GLOBAL ENTREPRENEURSHIP

Global entrepreneurs are limited only by their imagination as they can go anywhere online. They can export their own products or services or create a consultancy that serves as an intermediary representing companies abroad. Entrepreneurs well-versed in international goods and customs can also enter the shipping and global business arenas.

Leveraging e-commerce levels the playing field for smaller businesses to enter the global market. New trade agreements have also made provisions for e-commerce, making digital trade the wave of the future."

Paul Bobadilla, owner and visionary of Trinity CBC in San Pedro, CA started his coffee business from his garage. Although he had a great career in the film industry working for companies like Sony, Netflix, and Hulu, his desire to be his own boss motivated him to start a business.

One of his job responsibilities is sourcing the coffee beans. Paul said, "The global coffee supply chain is vast, and we want to partner with those willing and able to enhance our local and universal economy." Therefore, Trinity CBC only sources from ethical farms.

Paul attended Harbor Community College and Chapman University, but attributes his industry-specific skills to "reading a lot of articles and books, listening to coffee podcasts, and through learned experiences." Paul says taking affordable business courses in a local community college is not only smart, but can save you from making pricey mistakes with people, partners, and profit. And having a global mindset, some basic business skills, and becoming a subject matter expert are essential elements for new entrepreneurs.

A new report released in 2021 highlights the need to raise awareness of public sector career opportunities among community college students. "California has the highest number of federal employees outside the Washington, D.C. area, but agencies in the state still face challenges in attracting quality young talent. To address this issue, the Partnership and the James Irvine Foundation wrote a report examining how federal agencies in California can strengthen their talent pipelines by recruiting, hiring, and retaining job seekers without a four-year degree."

Opportunities in Global Commerce – Middle Skill Jobs at LA Basin Air and Sea Ports

Center for a Competitive Workforce has a new report about jobs in the seaport and airport industry in the Los Angeles Basin, to help community college faculty adapt programs to evolving skills requirements, give job-seekers insights on where the good wages are, and support pathways into these well-paying jobs. The report was co-authored by LAEDC's Institute for Applied Economics.

TIPS FOR PUBLIC SECTOR JOBS

The public sector is the part of the economy in which business organizations are wholly or partly owned by an agency of the federal or local government, and are controlled through a public authority. International career opportunities in this sector exist in federal and state agencies, as well as international and non-profit organizations.

- The job search and application process for public jobs is different from private jobs.
- The first step would be to create a Government Profile and take a Civil Service exam.
- From technician to paralegal, secretary to park ranger, most jobs at all levels of education do exist in the federal government - the largest employer in the United States.
- Treat the public sector as a continuous job search, not a one-off process. Public sector jobs at all levels pop up throughout the year, not just all at once on a specific date.
- Pay close attention to job requirements when applying for a position, and be prepared to show how your experiences are related to competencies and skills expected for the job.
- In your federal résumé use the language of the built-in template, so you are explicitly stating that your qualifications are aligned with their requirements.
- Consult resources such as The Partnership for Public Services' GoGovernment.org website for application tips, particularly in résumé writing.

There are many opportunities to work in global trade and logistics in the public sector in the Los Angeles Region. Ports and airports in Los Angeles are under city jurisdiction. San Pedro Bay Port Complex, which comprises of Port of LA and Port of Long Beach, is the 9th biggest Port Complex in the world. Both Ports are massive economic drivers contributing to 1 in 9 jobs or 171,000 jobs in LA and Long Beach and 1 in 40 jobs or 40 million jobs throughout the US.

Area Ports

Armando Ramos, an International Longshore and Warehouse Union (ILWU) Marine Clerk, is responsible for the flow of the cargo within the Port of LA and Long Beach when it enters the terminal. The containers are removed from the ship and placed into the designated import area, referred to as "the hub," so truck drivers can pick them up for delivery. In the railyard, he accounts for all inventory within the imports that are destined for truck or train delivery and ensures it is in the proper location to be removed from the yard. Ultimately, these units can be transported all across the country, to hubs such as Chicago.

Armando stresses that it is a team-oriented job. The shipping containers are capable of killing individuals if mishandled. It's a fast-paced environment, and is therefore ideal for individuals who are quick-thinkers and efficient multi-taskers. Armando's job also requires him to work alongside the same people, so when the team's communication is strong, they are truly a cohesive unit. Additionally, strong listening and communication skills are important when talking with many of the truck drivers, since many speak languages other than English.

FEDERAL GOVERNMENT CAREERS

The U.S. Government represents this country's interests and promotes trade abroad through many government departments and agencies.

Jobs involving international trade are increasing as the global economy becomes more interdependent and establishing connections with global partners becomes a necessity for success and expansion. Compensation in all government jobs is based on the General Schedule (or GS pay schedule) which contains 15 grades. GS-1 is the lowest scale and GS-15 is the highest. Within these grades are 10 steps that represent a pay increase within that level.

There are two classes of jobs in the federal government: civil service and non-civil service. Civil service jobs are under the jurisdiction of the Office of Personnel Management and subject to the civil service laws passed by Congress to ensure that applicants receive fair and equal treatment in the hiring process.

Non-service agencies function outside the civil service system. They may set their own gualification requirements and are not subject to the appointment, pay, and classification rules in Title 5 of the United States Code.

Identify what type of work you are interested in, and for which GS level you are gualified. GS-3 or 4 is the level for students/interns, while GS-5 and GS-7 are entry-level jobs, typically for recent graduates (generally including those with certificates or AA degrees) or those with equivalent work experience.

Create a saved search on USAJOBS, using filters (e.g. location, job classification, GS level, etc.) that match your career preferences. This will give a periodic update of the jobs that are available to you - particularly important because federal jobs are posted throughout the year, rather than all at once.

Make your federal résumé using the USAJOBS resume builder. Federal resumes are different from regular ones. Use the built-in template to fill it

Civil Service at the Agency for International Development

Civil Service at the Agency for International Development performs governmental functions and acts as the essential link between strategic interests and the program content and style selected to achieve that interest.

Border Patrol Agent

Border Patrol Agents are focused 24/7 on securing our international land borders and coastal waters between ports of entry. They safeguard the American people from terrorists and their weapons, drug smugglers, and illegal entry of undocumented aliens.

International Trade Specialist/Analyst

International Trade Specialist/Analysts are responsible for coordinating credit and financial activities and obtaining payments for import/export operations. Acts as an advisor on matters of tariffs, markets, and federal and foreign regulations.

Commercial officer

Commercial officers abroad promote U.S. exports and support the interests of American companies in project bidding and trade disputes.

Foreign Commercial Service Officer

Foreign Commercial Service Officers serve overseas to provide in-country leadership for U.S. export promotion programs.

Program Analyst

Program Analysts (National Security Program) are responsible for analyzing and evaluating the DOE's national security programs.

Consular Officer

A Consular Officer serving overseas protects the interests of American citizens traveling or living abroad. In this job, you'll assist Americans who have been in serious accidents or who have other emergencies.

Economic Officer

Economic officers are responsible for providing their post and Washington with information and analysis on significant economic developments in the host country.

Logistic Management Specialist
