LBCCD-LBCCFA Memorandum of Understanding COVID-19 Pandemic Response

This following Memorandum of Understanding ("Agreement") is made by and between the Long Beach Community College District ("District") and the Long Beach City College Faculty Association ("LBCCFA"). Where appropriate, The District and LBCCFA will collectively be referred to as "parties." This Memorandum of Understanding shall supersede any other agreement, either oral or written, previously agreed to by the parties related to the following:

- 1. The District will comply with all local and state directives related to what activities and which personnel may return to campus or may be required to work remotely.
- 2. Due to local and state health and safety orders, faculty may be required to teach online and will comply with all requirements for distance education as contained in the contract between the District and LBCCFA. This includes attaining certification for distance education as well as the evaluation processes for distance education.
- 3. The District and LBCCFA will jointly develop and present training to faculty on conducting online evaluations.
- 4. The LBCCFA President will be given an additional 10% reassign time in recognition of the additional time required to participate in meetings and other work related to the District's COVID response and discussions of remote working conditions for unit members.
- 5. Should any class or faculty assignment be suspended, in whole or in part, due to local or state health orders, the affected faculty will return, either during a succeeding primary or intersession term, to complete the assignment as scheduled by the Vice President of Academic Affairs. For faculty efforts to maintain contact with students, to continue to support and encourage retention and completion, a stipend of \$500 will be paid to each faculty member who returns in the Winter 2020 intersession to complete a suspended class and will provide evidence of such activities. Should the affected faculty have overload, they may use that to make up the reduced load caused by a class cancellation.
- 6. The District shall provide LBCCFA the list of classes/courses identified for suspended status if that should occur.
- 7. During the COVID-19 emergency response and temporary transition of courses to a remote format, contractually limits to online teaching loads shall be waived.
- 8. Tenured Faculty evaluations that were impacted due to the initial temporary transition to remote in Spring 2020 will be conducted as shown in the attached list.
- 9. Classroom student evaluations will be conducted during the semester in which the faculty is being evaluated.

10. For the academic year 20/21, the parties agree to amend the large class stipend as follows:

All other contract language related to large class stipends remains in effect.

- 11. The parties understand that due to health orders, flex activities may be conducted primarily online and therefore waive the contractual requirement of members completing at least (6) hours on campus.
- 12. For Spring 2021, the parties agree to waive the requirement of Article 11.8.3.8 requiring members to notify the District by the first day of Fall should they wish to use banked load in the following Spring. Faculty wishing to use banked load in Spring 2021, shall notify the district by the end of the 12th week of Fall 2021 term.
- 13. Execution: The Agreement may be executed in several counterparts and shall be deemed legally effective at such time as the duly executed counterparts have been furnished and delivered to the parties or attorneys for the parties to this Agreement.
- 14. Unless mutually agreed to by the parties, with the exclusion of section 8 above, this Memorandum of Understanding shall expire on August 27, 2021.
