

**RELEASE OF LIABILITY, WAIVER OF CLAIMS, HOLD HARMLESS, ASSUMPTION OF RISK,
INDEMNITY AND PHOTOGRAPHIC RELEASE AGREEMENT**

I realize that this is a volunteer activity of the Long Beach Community College District, Student Life – Viking Volunteer Program. I understand the activities associated with this program could cause serious illness and/or injury, and I assume all risks for any such illness and/or injury.

I voluntarily agree and accept on behalf myself and my heirs, next of kin, hereby release, remise and forever discharge and hold harmless the Long Beach Community College District and its Board of Trustees (hereinafter referred to as the “DISTRICT”), its officers, directors, servants or agents, and all persons associated with it, from any and all liability and claims whatsoever and/or responsibility whatever for accidents or injuries, including transportation to and from such event, whether fatal or otherwise, however arising and whether or not the DISTRICT is negligent or grossly negligent, which may in any way occur to the participant incidental or arising directly or indirectly out of the activity. I accept the premises and adjoining areas including the parking lots as is and understand that this activity could cause serious illness and/or injury, and I assume all risks for any such illness and/or injury. I understand that pursuant to the California Code of Regulations, Subchapter 5, Section 55220, by participating in this activity

I am deemed by law to have waived all claims against the DISTRICT or the State of California for injury, accident, illness or death occurring during or by reason of this activity. The undersigned hereby voluntarily releases, discharges, waives and relinquishes any and all actions of causes of action for personal injury, bodily injury, property damage or wrongful death occurring to him/herself arising in any way whatsoever as a result of engaging in said activity or any activities incidental thereto wherever or however the same may occur and for whatever period said activities may continue. The undersigned does for him/herself, his/her heirs, executors, administrators and assigns hereby release, waive discharge and relinquish any action or causes of action, aforesaid, which may hereafter arise for him/herself and for his/her estate, and agrees that under no circumstances will he/she or his/her heirs, executors, administrators and assigns prosecute, present any claim for personal injury, bodily injury, property damage or wrongful death against the District or any of its officers, agents, servants, or employees for any of said causes of action, whether the same shall arise by the negligence of any of said persons, or otherwise.

I hereby grant permission for the DISTRICT and those acting under its permission to copyright, use, publish, display, produce, duplicate, sell, and distribute the photographic, video, and sound recording of me, or my child as stated in the description above. I further grant permission for the DISTRICT to use segments of portions of the above product for announcements, informational film clips, or other uses necessary to provide information or advertisement for **Viking Volunteer Program**. The intended distribution of and use for this product is for the promotion of **Viking Volunteer Program**. I hereby release, discharge, and agree to hold harmless the DISTRICT and those acting under its permission from any liability to the extent permitted by law, for the preparation, distribution, and use of the product, as described above.

I am aware of the potential risks involved in this voluntary activity and I am fully aware of the legal consequences of signing this instrument.
